- 1 non-native and invasive to New Mexico, it is also depleting other 2 native plants and wildlife of valuable resources, such as 3 available water and access to sunlight. The Siberian Elm tree is an unsustainable specie that requires more resources to maintain 4 than it provides to wildlife. Due to its placement in the 5 unfamiliar terrain and climate of New Mexico, the Siberian Elm 6 7 tree's life span is drastically reduced, and each tree will 8 eventually require state funds to be properly removed upon termination. By prohibiting the importation, distribution, and 9 10 transportation of the Siberian Elm tree within New Mexico, the ecosystem of New Mexico will be more sustainable and prosperous. 11 PENALTY: If an individual were to violate the terms of the bill, 12 they shall be punished by a fine on not more than \$10,000 13 (depending on magnitude of violation) or by imprisonment for a 14 definite term not to exceed 180 days, or both. 15 16 17 APPROPRIATION: 18 19 All laws, acts, provisions, or parts of laws contained in the Constitution of the State of New Mexico in conflict with any provision of this act are herby repealed. 20
