- 7 **DEFINITIONS:** This is not a mandatory section but should be used with certain terms used
- 8 in the act that need to be defined or when it is desirable to substitute a single word for a
- 9 long phrase that will be used many times. Do not define words that are being used in their
- 10 normal dictionary meaning. List defined terms alphabetically. Enclose defined terms in
- 11 quotation marks.
- 12 **EXAMPLE:** SECTION 1. DEFINITIONS. As used in the Fish Act:
- A. "department" means the department of game and fish;
- B. "fingerling" means a fish shorter than six inches in length;
- 15 C. "fish" includes both game fish and nongame fish, but does not include carp;
- D. "fund" means the fish replenishment loan fund;
- E. "hatchery" means a fish farm licensed by the department and the federal department

- 22 MAIN PROVISION SECTIONS: This mandatory section lists the main provisions of the bill

1 **EXAMPLE:** SECTION 2. PERMITS. – Permits shall be obtained from the pigeon protection 2 board for the purpose of... 3 **PENALTY:** This is not a mandatory section but if choosing to enforce a penalty use the 4 5 following format "... shall be punished by a fine of not more than (\$) or by 6 imprisonment for a definite term not to exceed , or both." **EXAMPLE:** SECTION 3. REMOVING BONES – PERSONAL USE – PENALTY. – Any 7 person who removes bones from public property for personal use is guilty of a 8 9 misdemeanor and shall be punished by a fine of not more than five thousand dollars (\$5,000) or by imprisonment for a definite term not to exceed one year, or both. 10 11 12 **APPRIOPRIATION:** This is not a mandatory section but if creating a bill that requires funds be appropriated for its use then it must be included. Required items include the amount of 13 money, the source for the money, where the funds are going to, the time period the money 14 can be used, the purpose for the funds and what will happen to any moneys remaining after 15 the time period ends. If including this section in your bill you must include the phrase 16 "MAKING AN APPROPRIATION" into the full title of your bill. 17 **EXAMPLE 1:** SECTION 4. APPROPRIATION. – Twenty-five thousand dollars (\$25,000) is 18 19 appropriated from the general fund to the orchard inspection commission for expenditure in 20 fiscal year 2024 to carry out the provisions of the Prune Act. Any unexpended or 21 unencumbered balance remaining at the end of the fiscal year 2024 shall revert to the 22 general fund. 23 **EXAMPLE 2:** SECTION 4. APPROPRIATION. – One hundred thousand dollars (\$100,000) 24 is appropriated from the general fund to the tree farm fund for expenditure in fiscal year

2024 and subsequent fiscal years to provide loans to tree farmers as provided in the Tree

- 1 Farm Loan Act. Any unexpended or unencumbered balance remaining at the end of a fiscal
- 2 year shall not revert to the general fund.

- 4 **REPEAL:** This is mandatory in bills and should be an exact copy.
- 5 All laws, acts, provisions, or parts of laws contained in the Constitution of the State of New
- 6 Mexico in conflict with any provision of this act are hereby repealed.

- approval by the American Legion Auxiliary New Mexico Girls State Governor or it's
