8 **RELATING TO GUN-FREE ZONES; AMENDING RESTRICTIONS ON ZONES;**  
9 **SPECIFICATION ON ALLOWANCE**

11 BE IT ENACTED BY THE LEGISLATURE OF THE AMERICAN LEGION AUXILIARY NEW  
12 MEXICO GIRLS STATE:

13 SECTION 1. DEFINITIONS

14 A. “Concealed carry license” means a license given by the state allowing you  
15 to legally carry a handgun concealed.

1 B. "Gun-Free Zones" means the zones around schools that are illegal to  
2 have any type of gun within those zones.

3 C. "handgun" means a gun designed for use by one hand, especially a pistol  
4 or revolver.

5 SECTION 2. Gun-Free Zones. – Gun free zones shall no longer ban all guns but all  
6 of those except those held by a person with a current New Mexico issued Concealed  
7 Carrying Permit. Those with that certification will be legally allowed to carry a hand  
8 gun, under which they got a permit with, in a "Gun-Free Zone" though they must  
9 abide by the standard rules of carrying a gun at all times. They MUST show have  
10 proof of this permit on them at all times that they are carrying their handgun. They  
11 will be allowed to carry those handguns into any building within the gun-free zones.  
12 Those persons do not have to notify anyone one within the building that they are  
13 carrying unless asked by a person of authority. This does not apply to open carrying,  
14 illegally carrying, and any other way to have a firearm or any other type of firearm  
15 besides those mentioned above.

16  
17 SECTION 3. Rules- The weapon must be covered completely at all times, and must  
18 not have a noticeable bulge from your handgun. It also must be on your person at all  
19 times. And cannot be in a purse, backpack, bag or any other containing device that  
20 could be left or set down somewhere, besides a jacket. You are only allowed to carry  
21 one gun on you at a time.

22  
23 PENALTY: If found carrying in any other way besides above the punishments will be  
24 the same as before.

- 1 All laws, acts, provisions, or parts of laws contained in the Constitution of the State of New
- 2 Mexico in conflict with any provision of this act are hereby repealed.
